In consideration of our child being permitted to enroll as a camper at Shadow Mountain Horse Camp we fully and completely release and discharge Shadow Mountain and its owners and employees, from any and all claims that either we or our child might have for damages or injuries arising from use of or working with horses, or from any other camp activities, and we agree to indemnify Shadow Mountain Farm, Inc. from any such claims made by or on behalf of our child.

Important Information and Camp Policies

- **To Enroll:** Send a completed and signed Enrollment Form along with a \$150.00 deposit (non- refundable) to Betsey Knight at Shadow Mountain Farm.
- **Payment:** Balance of tuition is <u>due no later than 2 weeks</u> before camper's arrival at camp. Those who wish to do so may prepay the tuition in installments - in whatever amounts and at whatever time they choose. Although the deposit is not refundable, these prepayments are refundable until 2 weeks before arrival at camp. *If balance is not received when due the camp director has the right to give that space to a child on the waiting list.
- After Enrollment: After we receive your enrollment, we will send a "Things To Bring List" and "Medical Record" (usually mailed out in late April). The Medical Record must be filled out and signed by the parents, then mailed back to camp by the tuition balance due date (2 weeks before arrival at camp).
- **Refunds:** Except for the deposit, all tuition paid in advance is fully refundable until the due date (2 weeks before arrival at camp). After the due date the tuition is not refundable for any reason, including withdrawal or dismissal. *The single exception if a camper must leave camp for medical reasons, the unused portion of the tuition will be refunded.
- **Please Note:** The camp director reserves the right to dismiss without refund any camper whose presence, in their judgment, is detrimental to the camp, to the other campers, or to the camper herself.
- **Session Change:** Choice of sessions may be changed at any time if space and circumstances permit.
- **Visiting:** There is <u>no visitation</u> during camp as it can be disruptive to the schedule. We also strongly feel that one of the benefits of going to camp is to gain in self reliance and confidence. Usually the parents have a harder time with this then the campers!
- **Phone Calls:** The phone at Shadow Mountain is for <u>emergency use only</u>. Campers will not be allowed to receive calls or make them, except under special circumstances determined by the director.
- Electronic Devices: Leave them at home. That is not what camp life is all about.
- **Candy, Bottled Water and Beverages:** No food or candy is allowed to be kept with camper's belongings. Any food or candy brought by campers or sent by parents will be kept with the director and divided up among the campers in appropriate amounts and at appropriate times. <u>NO GUM</u> is allowed at camp. <u>NO BOTTLED WATER</u>. Bring a water bottle to refill at camp, not bottles of drinking water or other beverages. This causes too much trash and a litter problem around camp.
